

**Wissahickon School District**  
**STUDENT/PARENT AGREEMENT FOR USE OF COMPUTER**  
**Grades 6-8**  
**2018-2019**

In this agreement, "Computer" means Computer and all its components, software, and battery charger.

**Terms:** You will pay a non-refundable annual equipment use and insurance fee for accidental damage coverage subject to policy terms ("Computer Protection Fee") of \$30.00 before taking possession of the Computer. Once possession of the Computer has occurred, refunds are not allowed.

You will comply with, and be bound by, at all times the 21st Century Teaching & Learning Initiative Mobile Computer Guidelines for Parents & Students, as well as the District Policies titled "District-Issued Computers – Student Use, Rights & Responsibilities" (Policy #146) and "Acceptable Use of District Information and Telecommunications Resources By Students" (Policy #256). Any failure to comply may terminate your rights of possession effective immediately and the District may repossess the Computer. The Computer is to be carried in the district-issued protective case at all times. The Computer is assigned to a single individual and is not to be shared.

**Title:** Legal title to the Computer shall be held by the Wissahickon School District and title shall remain with the District. The student's right of possession and use is limited to and conditioned upon full and complete compliance with this Agreement and the 21st Century Teaching & Learning Initiative Mobile Computer Guidelines for Parents & Students and District Policies 146 and 256.

**Loss or Damage:** If the Computer is damaged, lost or stolen, the parent/guardian is responsible for the reasonable cost of repair or its fair market value on the date of loss. Loss or theft of the Computer must be reported to the District by the next school day after the occurrence and a police report may be required.

- Computer: Dell Latitude 3340/3350/3380 Laptop
- Limited Accidental Damage & Equipment Fee: **\$30/year**
  - Covered (Liquid spills on or in unit, drops & falls, electrical surges) – Student is entitled to a maximum of one (1) incident during the twelve months following the first or previous incident.
  - Not Covered (Fire, intentional damage, loss/theft, cosmetic damage)
- Student deductible for total loss from theft/misplacement: \$477 (prorated per year)

If the Computer is lost and/or significantly damaged on two occasions at any time following issuance to a Student, the Student will be required to pay for the parts required to repair it. All fees herein may be increased as a result of repeated damage to a Computer.

**Repossession:** Students not complying with all terms of this Agreement and the 21st Century Teaching & Learning Initiative Mobile Computer Guidelines for Parents & Students and District Policies 146 and 256, including the timely return of the Computer, will be declared to be in default and authorities may be sent to your place of residence, or other location of the Computer to take possession.

**Term of Agreement:** Your right to use and possession of the Computer terminates no later than the last day of classes during the school year of your graduation from the District, unless earlier terminated by the District or upon student withdrawal from the school district.

**Appropriation:** Your failure to timely return the property and the continued use of it for non-school purposes without the school's consent will be considered unlawful appropriation of school property.
